Executive Summary

The following report is the Community Health Needs Assessment (CHNA) prepared for Audubon County, Iowa. Creating healthy communities requires a high level of mutual understanding and collaboration with community individuals and partner groups. The development of this assessment brings together community health leaders and providers, along with local residents, to research, prioritize county health needs, and to document community health delivery successes. This health assessment will service as the foundation for community health improvement efforts for the next three years.

Important Community Health Needs Assessment benefits are as follows:

- 1. Increases knowledge of community health needs and resources
- 2. Creates a common understanding of the priorities of the community's health needs
- 3. Enhances relationships and mutual understanding between and among stakeholders
- 4. Provides a basis upon which community stakeholders can make decisions about how they can contribute to improving the health of the community.
- 5. Provides a rationale for current and potential funders to support efforts to improve thehealth of the community.
- 6. Creates opportunities for collaboration in delivery of services to the community
- 7. Provides guidance to local health agencies for how they can align their services and community benefit program to best meet health needs.

Based upon the comprehensive Community Health Needs Assessment Survey and the community forum, the following priorities were determined:

- 1. Mental Health Services, Drug/Alcohol Abuse, etc.
- 2. Cancer and Oncology Services
- 3. Preventative Services and Healthcare Services
- 4. Aging Services
- 5. Economic Opportunities, Infrastructure, Housing, Living Wages

Scope and Purpose

Audubon County Memorial Hospital and Clinics, Audubon County Public Health, Friendship Home, Exira Care Center, New Opportunities, and Carroll Area Nursing Services are all committed to conduct a Community Health Needs Assessment at least once every three years and adopt a strategy to meet community health needs.

The purpose of the Community Health Needs Assessment (CHNA) is to:

- 1. Evaluate current health needs of the community and prioritize them
- 2. Identify resources available to meet both the priorities as well as opportunities identified through the CHNA
- 3. Develop an implementation plan to address health priorities
- 4. Build capacity to address the opportunities within the context of the health system's existing programs, resources, priorities, and partnerships.

Requirements of CHNA

The requirements of the Community Health Needs Assessment Report include:

- A description of the community served and how the community was determined.
- A description of the process and methods used to conduct the CHNA.
- Identification of any and all organizations with which the organization collaborated and third parties that engaged to assist with the CHNA.
- A description of how the input was gathered from persons representing the community, who those people are, and their qualifications.
- A description of the existing health care facilities and other resources within the community available to meet the needs identified through the CHNA.

Overview of CHNA Survey

Audubon County healthcare organizations partnered together to conduct a community health needs assessment survey as a way to gather input from people throughout our service area regarding their perceptions of the current state of our population's health and what they believe are the most important health needs that our communities should address.

The survey was created using Survey Monkey and was available online on the Facebook pages of Audubon County Memorial Hospital and Clinics, Audubon County Public Health, and other community sites. A link was also posted on the ACMH website. The survey was also available in paper form in several locations throughout the county for people to take. The paper copy drop-off boxes were emptied on a weekly basis and manually entered into the survey database. The survey was available from July 29 through August 30.

There were two press releases sent out to both county newspapers with information about the CHNA survey and how to complete it. There were presentations and information given to various groups and organizations throughout the community encouraging people to take the survey.

The survey ended with 309 total responses from people throughout the entire county including Leon, Lamoni, Davis City, Grand River, Audubon, Weldon, and Van Wert.


- Welcome/Introductions/Partnerships/Purpose


Community Forum Health Needs Priorities

Health Improvement Plan

1. Mental Health Services, Drug/Alcohol Abuse, etc.

Action Plan:

- Secure additional mental health services in community Lois Potthoff, LMHC to begin services at ACMH with emphasis on children and trauma. Will consider additional services for adults if needed.
- ACMH will provide trained ARNP to establish substance abuse medication contracts through the Medication Assisted Treatment program.

2. Cancer and Oncology Services

3. Action Plan:

• Contract secured with Dr. Robert Warner to provide oncology services at ACMH.

4. Preventative Services and Healthcare Services

Action Plan:

- Establish weight loss clinic at Audubon Family Health Care
- Expand Health Coach services at ACMH
- Improve transitions of care with ACMH and Community Partners

5. Aging Services

Action Plan:

• Hire additional physician to expand chronic care management

6. Economic Opportunities, Infrastructure, Housing, Living Wages

Action Plan:

- Work with Audubon Economic Development Group to build more affordable housing options including rental properties.
- Hospital to explore housing on the plot of land they own next to the hospital.
